Presentation of information

This document presents the Pillar 3 disclosures for Coutts & Company (Coutts & Co) at 31 March 2025. It should be read in conjunction with the Q1 2025 NatWest Holdings Group Pillar 3 report, which is published in the same location at: investors.natwestgroup.com/reports-archive/2025

Coutts & Co is incorporated in the United Kingdom and is a large, non-listed subsidiary of NatWest Holdings Limited (NWH Ltd). NatWest Group plc is 'the ultimate holding company'. The term 'NatWest Group' refers to NatWest Group plc and its subsidiary and associated undertakings.

Based on the criteria set out in the UK CRR, NatWest Group primarily defines its large subsidiaries in scope of PRA Pillar 3 disclosures as those designated as an Other Systemically Important Institution (O-SII) by the PRA or those with total assets equal to or greater than €30 billion.

The disclosures for Coutts & Co are calculated in accordance with the UK CRR (split across primary legislation and the PRA Rulebook) and presented in accordance with the Disclosure (CRR) part of the PRA Rulebook. Any rows or columns that are not applicable have not been shown however explanations have been added as appropriate.

The liquidity disclosures completed at UK Domestic Liquidity Subgroup (UK DoLSub) level are published in the NatWest Holdings Group Pillar 3 report. The UK DoLSub waiver allows NWB Plc, RBS plc and Coutts & Co to manage liquidity as a single sub-group rather than at an entity level.

In this report, in line with the regulatory framework, the term credit risk excludes counterparty credit risk, unless specifically indicated otherwise.

The Pillar 3 disclosures are presented in pounds sterling (£) and have not been subject to external audit.

Coutts & Company - Key points

CET1 ratio

10.9%

(Q4 2024 – 11.3%)

The CET1 ratio decreased by 40 basis points to 10.9% due to a £0.3 billion increase in RWAs and an immaterial decrease in CET1 capital.

RWAs

£10.9bn

(Q4 2024 - £10.6bn)

Total RWAs increased by £0.3 billion to £10.9 billion mainly reflecting an increase in operational risk RWAs of £0.2 billion following the annual recalculation and an increase in credit risk RWAs of £0.1 billion driven by increased lending growth partially offset by active RWA management.

UK leverage ratio

7.4%

(Q4 2024 – 7.5%)

The leverage ratio decreased by 10 basis points to 7.4% due to a £0.2 billion increase in the leverage exposure and an immaterial decrease in Tier 1 capital. The key driver in the leverage exposure was an increase in other financial assets.

(2) Coutts & Co elected to take advantage of the IFRS 9 transitional capital adjustments in respect of ECL provisions, which were maintained until 31 December 2024. Prior period comparatives for CET1 capital, RWAs and leverage include the impact of those adjustments where applicable

(3) The institution specific countercyclical capital buffer (CCyB) requirement is based on the weighted average of the buffer rates in effect for the countries in which institutions have exposures. The UK CCyB rate is currently being maintained at 2%.

(4) Coutts & Co is not an LREQ firm therefore not subject to the additional leverage ratio disclosure requirements.

(5) Under the UK DoLS waiver Coutts & Co liquidity and funding is managed and disclosed at the sub-group level rather than entity level.
