Presentation of information

This document presents the interim Pillar 3 disclosures for The Royal Bank of Scotland plc (RBS plc) as at 31 March 2025. It should be read in conjunction with the Q1 2025 NatWest Holdings Group Pillar 3 report, which is published in the same location at: investors.natwestgroup.com/reports-archive/2025.

RBS plc is incorporated in the United Kingdom and is a large, non-listed subsidiary of NatWest Holdings Limited ('NWH Ltd'). NatWest Group plc is 'the ultimate holding company'. The term 'NatWest Group' refers to NatWest Group plc and its subsidiary and associated undertakings.

Based on the criteria set out in the UK CRR, NatWest Group primarily defines its UK large subsidiaries in scope for PRA Pillar 3 disclosures as those designated as an Other Systemically Important Institution (O-SII) by the PRA or those with total assets equal to or greater than \in 30 billion.

The disclosures for RBS plc are calculated in accordance with the UK CRR (split across primary legislation and the PRA Rulebook) and presented in accordance with the Disclosure (CRR) part of the PRA Rulebook. Any rows or columns that are not applicable have not been shown however explanations have been added as appropriate.

The liquidity disclosures completed at UK Domestic Liquidity Subgroup (UK DoLSub) level are published in the NatWest Holdings Group Pillar 3 report. The UK DoLSub waiver allows NWB Plc, RBS plc and Coutts & Co to manage liquidity and funding as a single sub-group rather than at an entity level.

In this report, in line with the regulatory framework, the term credit risk excludes counterparty credit risk, unless specifically indicated otherwise.

The Pillar 3 disclosures are presented in pounds sterling ('£') and have not been subject to external audit.

RBS plc - Key points

CET1 ratio

12.7%

(Q4 2024 - 11.1%)

The CET1 ratio increased by 160 basis points to 12.7% due to a $\pounds 0.3$ billion increase in CET1 capital. RWAs remained static in the period. The CET1 capital increase was mainly driven by an attributable profit in the period of $\pounds 0.3$ billion.

UK leverage ratio

6.6%

(Q4 2024 - 5.8%)

The leverage ratio increased by 80 basis points to 6.6% due to a £0.3 billion increase in Tier 1 capital and a £1.3 billion decrease in leverage exposure. The key driver in the leverage exposure was a decrease in other financial assets.

RWAs

£17.6bn

(Q4 2024 - £17.6bn)

Total RWAs remained static at £17.6 billion. An increase in operational risk RWAs of £0.2 billion, following the annual recalculation, was offset by a decrease in credit risk RWAs.
